The Bossier Parish Communications District One Board in regular and legal session convened on August 21, 2023, at 5:30 pm at the Bossier Parish Communications District One Board room at 4601 Palmetto Road in Benton, Louisiana.

Chairman Varnell called the meeting to order.

Mr. McAnn opened in prayer.

Mr. McAnn informed the board that the district will host the North Louisiana0 911 Directots group at the Backup Center on September 21, 2023. Mr. McAnn also stated that in-service training for the staff would be held on September 19, 2023. Mr. McAnn then announced the upcoming retirement of long-time Communication Officer McDonald in October. He informed the board that he had begun the interview process to fill the vacancy Mrs. Mcdonald's retirement would create. Mr. McAnn stated he had spoken with Shreveport Communications, and they are waiting on a few critical parts before equipment installation begins on the radio infrastructure and console projects. Mr. McAnn informed the board that all building repair projects have been completed, and the carport for staff parking should be installed before winter. Finally, Mr. McAnn reported ATT was still working on the call-handling equipment (Viper) upgrade quote.
